Years 2016-2017 - 1.99% wage increase

Years 2017-2018 – 1.99% wage increase

Insurance increase in deductibles - Second year moves Core Plan to HSA with buyout to PPA.

Cindy Lavalette stated that there is a language change in layoffs as to seniority. Language was added to allow paraprofessionals to ask for unpaid leave for special occasions.

Councilor Fishbein inquired about the steps and that there are only nine? Cindy Lavalette replied yes and explained that there are only nine steps and after that they get general wage increases.

Councilor LeTourneau asked where everyone is in the step process. Cindy Lavalette responded that everyone starts at Step 1 and noted that most of the paraprofessionals are at the top step now.

Councilor Shortell asked if Board of Education has an HSA now. Cindy replied no and went on to explain that the reason they will wait until the second year for HSA is to build the bank for this.
