THE BOE IS ELECTED BY THE VOTERS OF WALLINGFORD; THEREFORE, THEY ARE RESPONSIBLE TO THE VOTERS OF WALLINGFORD VIA THE TOWN CHARTER.

THE BOE HAS TO FOLLOW THE WALLINGFORD TOWN CHARTER AS STATED IN THE TOWN CHARTER.

In my discussions with Attorney Harris of legal affairs, State Department of Education, the following conclusions were arrived at:

- 1. The Wallingford BOE shall (mandatory) follow all mandates of the state and have general supervision and control of the educational interest of the Town of Wallingford as per these state educational laws and mandates.
- 2. The Wallingford DOE shall (mandatory) follow the Town Charter and ordinances as adopted.
- * The legislative power of the town shall (mandatory) be vested exclusively in the council except as otherwise provided in Sec. 8.
- * The council, by a vote of three (3) members, shall (mandatory) have powers to investigate any and all departments, offices, and agencies (including DOE).
- * The Mayor shall (mandatory) see that all laws and ordinances governing the town are faithfully executed (including DOE).
- * The Department of Finance shall (mandatory) be responsible for the keeping of accounts and financial records (including DOE).
- * The Purchasing Agent of the town, pursuant to such rules and regulations as established by ordinance, shall (mandatory) contract for and purchase all items. (except DOE instructional items as defined on State BOE form #ED001)
- 3. The educational budget is a very important document and should be reviewed very closely by line item. At the end of each year the actual educational expenditures should be compared to the budget. This will show the control, knowledge and financial capabilities of the local Board of Education. If in certain areas monies budgeted were not required, transferred or not handled in the best interest of the school district (i.e. the town) those line items may be reduced and/or monitored closely. If monies are being misused and funding is required by State law, the Town can file a complaint to the State BOE. There should be no slush funds, contingency funds, etc. Any interest from any line items and surplus monies should be passed to the general fund. The DOE is not an entity but a department of the town.

The town, as per the Town Charter, controls the spending of its departments. If additional funds are required due to poor budgeting or an unexpected line item overrun, that department can ask for additional monies to continue operation by going before the Town Council.

Instructional items are defined by use. These should be checked at audit and budget time. It would be fraud if non-instructional items were classified as instructional.

SUMMATION

The State of Connecticut has estalished a minimum level of educational standards that must be met by all towns, which the State of Connecticut calls "school districts". The state BOE by charter is interested only in the control and general supervision of a minimum level of education for all persons from the age of seven years old to sixteen years old and grades kindergarten through twelfth grade. The state also realized that a burden would be put on some towns (i.e. school districts), therefore, monies or things of value would have to be available to some or all towns. Since this would be state and/or federal monies, control of these items and these monies would be tracked by the state.

To accomplish the minimum level of control and general supervision of education for all children in the state and the tracking of state grants, the Connecticut State Board of Education was put into existence.

The State Board of Education, by law, has under its guidelines the local Board of Education. The local BOE can't have, by State law, any additional powers than was given to the State Board. Therefore, they are responsible for educational standards of the town. These standards must equal or exceed state levels.

All local board members are elected by registered town voters and must live in the town (ie. school district). These members of the board report to the voters as required by the Town Charter.

The Town Charter, by state law, must allow a very limited amount of "special considerations" this will allow the local BOE to obtain the minimum education standards and allow state grants to flow into the town and be tracked.

It also must be noted that the same type of "special considerations" have been handled by the Charter for the Public Utilities Commission (PUC).

The state BOE does not have any control or desire to watch the local BOE in any areas that the State BOE does not have control. The Town officials and Town Departments have the legal obligation to the voters and taxpayers of the town to enforce all laws of the Charter.

This includes: Finance, Purchasing, Ethics, Legal, Contracts, and Budgets, etc.

I am sure every taxpayer wants the finest school district that we can afford.

The pendulum of checks and balances has swung out of control. We have a responsibility to the taxpayers to review all aspects of our BOE as soon as possible then make adjustments as good business decisions warrant. The Charter gives that right and obligation to the council and Mayor.
