Judge Wright: Congratulations, Mr. Mayor

Mayor William W. Dickinson, Jr. – "The agenda calls for me to make a few remarks so I guess I will take advantage of the moment to do so. It is a delight to see all of you here and certainly we appreciate your presence and interest. I congratulate all of the other elected officials who are here. We undertake serious responsibilities for the next two years. This ceremony is one that follows an election. During the election much is discussed about our community; its needs; and our plans for this new term of office. We have discussed budgets and revaluations, school projects, housing for the elderly, open space, electric rates and recreation. I could talk further about these but it reminds me of a little story. A woman writes that the morning following the ' irth of their first child the husband was mistakenly directed to the room of another new mother

n the maternity floor. He walked into the room, bent over the napping mother whose back was turned to him and gave her a big kiss. The woman turned and was startled to see a stranger. Before she could say anything, the husband smiled and said, "I didn't know having a baby would change you so much." The new year is yet a baby but our priorities have not changed. We live in a great town with a thriving civic spirit and active patriotism. There are challenges which need attention; some have been mentioned; others include caring for one another and understanding our differences. Our great attribute is our willingness to work together for goals which enhance the total community. I want to mention two things in relation to our work for the next two years; one concerns the great gift of time. It is important that we allow enough time for our plans to develop. There is a true story that comes our of Louisville, Kentucky. It involved a woman strolling through a park with a Polaroid camera on her shoulder. She was headed for a picnic. It was a beautiful day. Suddenly she heard steps running up behind her. Someone jerked at her arm, grabbed the camera and took off through the woods. A patrol officer heard her scream and set out to render her assistance. Shortly thereafter, about a quartermile away, the perpetrators were in a grove of woods checking out this camera. They each took the other's picture but what came out of the camera was just black; the camera wasn't working. They tossed these pictures on the ground and decided they would go off to a pawn shop to see --- hat they could get for the camera. Along the way they took pictures of a variety of other

ings. Each time, the pictures came out black so they tossed it on the ground and headed on their way. The police, who were in hot pursuit, found this trail of breadcrumbs, the developing pictures. As we know, Polaroids don't instantly develop, it takes a little time. They had no time! They couldn't wait. The police ended up with pictures of them and everything that they had taken a picture of and were apprehended. This is what we need to keep in mind; we need to give our plans time to develop. Remember this; Stephen Wright, comedian states, "Everywhere is within walking distance, if you have the time." Hodding Carter, United States politician and journalist states, "There are only two lasting bequests we can hope to give our children; one of these is roots; the other is wings." Roots and wings! Sounds like a contradiction, but only in the physical sense. Personalities, goals and dreams have the best

Robert Fulghum and his book, "It was on fire when I lay down on it", I have mentioned it before; I love that title; "It was on fire when I lay down on it" makes you want to ask all kinds of questions about the circumstances. In his book he provides his list of nine recommendations. Then he mentions that we know about the ten commandments and we know about Murphy's Law and, of course, Murphy's Law states that, no matter what you do, it probably won't work out right. Robert Fulghum has his own recommendations; "1) buy lemonade from any kid who is selling it; 2) any time you can vote on anything, vote; 3) attend the twenty-fifth reunion of your high school class; 4) choose having time over having money; 5) always take the scenic route; 6) give at least something to any needy person; 7) give money to all street musicians; 8) always be someone's valentine; and 9) when the circus comes to town, be there." I guess I would add, the world needs smiles and a little fun, at times. Let's be part of it. And if you appen to be worried about the value of things, remember James Brewers comment when he said, "A smile increases your face value." Thank you very much.

ELECTION AND SWEARING-IN OF TOWN COUNCIL CHAIRMAN

Mayor Dickinson stated, the floor is open for nominations for the position of Town Council Chairman.

Councilor Gerald E. Farrell, Jr. stated, "Mr. Mayor, members of the Town Council, distinguished citizens and guests, I would like to put into nomination for the position of Town Council Chairman, the name of a man who has served this town in many ways for many years. We all know this person for his variety of different talents. One of his more unknown talents came to light during the recent election.
