5. PUBLIC QUESTION & ANSWER PERIOD

Robert Gross, 114 Long Hill Road, asked about Rt. 150, Garden Road, aquifer areas in town and water-shed areas in town with respect to DEEP guidelines. Public Works Director McCully stated that street sweepings will be handled now on an annual basis and that he will ask DEEP to comment on snow disposal at the Garden Road location.

Dana Camp, 19 Lee Avenue, asked about jersey barriers at Simpson Court rear. It was stated that this is private property. He commented on job inspections within forty-eight hours.

Bill Comerford, 5 Broadview Drive, line striping in relation to an \$8,000 credit to the town.

6. Discussion and Possible Action regarding AFSME Co 15, Local 1570 Police Union /Arbitration Award – Personnel

In attendance: Dennis Ciccarillo, Labor Attorney for the Town of Wallingford Terence Sullivan, Director, Personnel Department

Councilor Rascati read the item.

Mr. T. Sullivan reviewed the highlights of the four-year contract for the Town Council that included details with regard to wages and medical coverage for the duration of the contract.

Wallingford Town Hall, 45 South Main Street

He noted that following the 0% increase in 2012 first-year that there is a wage re-opener in the fourth year of the contract, effective July 1, 2015. He recommended that the Town Council accept the contract.

The Town Council commented and asked questions with regard to negotiated terms versus arbitrated terms. Arbitration has cost attached to it. Councilors liked the contract but would like to see more discussion to negotiate wage terms rather than go to arbitration, which generally renders an expense of approximately \$18,000 to \$20,000. In the case of this contract medical terms were negotiated but not wages, which went to arbitration. Mr. Terence Sullivan stated that the wage increases were covered. He also added that in the case of medical insurance that the Town's Charter requires that this item go to bid every five years. He noted that it went to bid two years ago and Anthem gave a lower bid.

7. Discussion regarding granting a sewer lateral easement in Town Right-of-Way Masonic Avenue and Clinton Place - Mayor

In attendance: Roger Dann, General Manager, Water-Sewer Jim Wolfe, Property Owner, 5 Masonic Avenue

Councilor Fishbein stated that he will abstain from the discussion declaring a business conflict

Councilor Rascati read the letter the Mayor sent to the Town Council that outlined Mr. Wolfe's connection to the sanitary sewer system via an easement from the town.

Mr. Wolfe showed the path of the sewer line via use of a map. He reported that he will be responsible for the cost of installing the sewer line at approximately \$35,000 and the cost of the appraisal obtained by the Town at \$6,500. Mr. Wolfe worked with the Sewer Department and the Engineering Department, and it was determined that this is the only way to solve the problem to connect the sewer service to the building at5 Masonic Avenue.

Mr. Dann explained that the other properties in the area already utilize the sanitary sewer and that this extension will serve only one property to solve the problem for this property.

No Comments from the Public.

Attorney Small said that no motion could be entertained since this item was on the agenda for discussion and that the documents will come at a follow-up meeting. She said that Mr. Wolfe needed an indication as to the position of the Council on this before he could take more steps in his process. She added that she thinks the Council has indicated that they are supportive of this.

8. Discussion and possible action on the progress, status timeline and reasonably anticipated punch list for completion of the parking lot improvements to the Wooding-Caplan site, and areas surrounding the site with reports from:

John Thompson, Town Engineer

Councilor Fishbein briefly reviewed the timeline history of the Wooding-Caplan property in the completion of the parking areas, stating that he feels promises have been broken. In response to Councilor Fishbein's question, Mr. Thompson said that with regard to the plan for the space all is done in his department that should be done. He said that they survey every day and will continue to do so every day. Mr. McCully reviewed installation dates for various types of piping noting red rock problems. They discussed curbing and the various types of surfacing from millings to permanent surface. They discussed the underground conduit, pedestrian ramps, sidewalks, lighting, ornamental lighting, bicycle rack placements and parking signs to direct the public. Some of the work is contingent upon the weather and on whether Tilcon can perform certain work when it needs to be done or if Public Works must step in to do the work. Mr. McCully stated that of the three top areas that his department is working on, Wooding Caplan is first and at the top of the list. Both McCully and Mr. Thompson said the parking lot will be ready for Celebrate Wallingford minus some of the trimming details, which will come at a later time. Lucille Casagrande, Turnberry Lane, was concerned that there was no mention of green space or trees. Geno Zandri, Balsam Ridge Circle, asked about millings. Robert Gross, Long Hill Road, wanted to know if any grant, such as the STEAP grant, had been applied for. Bill Comerford, Broadview Lane, asked for the cost of the whole project, including Public Works labor. Larry Morgenstein, 177 North Main Street, commented on energy efficient lighting for the project.

9. Discussion and possible action on putting 41 South Main Street, the former American Legion Building, out to bid – Councilor John Letourneau

Councilor Rascati read the question. Councilor Letourneau, responsible for requesting this agenda item, stated that in the last one and one-half months, he has had three (3) different parties show an interest in purchasing the former American Legion Building and that two of them are interested in making the building a single family residence, and the third party would like to create apartments. He suggested that another RFP, using the same language as the last RFP, be used, so that these parties can put in their offers. It was determined that the language for the sewer line problem was in the last RFP. Councilors were reminded that no one showed interest in the building that last time. The sewer problem language would be in this RFP as it is already there. Ray Rhys, Gina Morgenstein and Lucille Casagrande all commented.

Some Councilors stated that they will support this RFP but that it will be their last time in supporting an RFP for this property.
