Cindy Lavalette explained that this is a 68 member union and a two year contract. She went on to say that a 2% wage increase is for the top step members and that there is no wage increase for non-max step employees. She then stated that 16 positions are being reduced in length of work year and retirees are not being replaced.

Councilor Fishbein stated that 25 of the 68 members are getting 2% and most of the others are getting 5% with the step increase.

Councilor Shortell stated that he doesn't know why we vote on these contracts and he went on to say that no action by the Council is an automatic approval of contract.

Councilor Marrone stated that he is voting no because he does not know why we go through this exercise.

Councilor LeTourneau stated that this is not an exercise and he thinks the taxpayer should know our thoughts on these contracts.

Chairman Cervoni stated only the top step employees will receive the 2% increase.

Councilor Shortell clarified that he was not calling the contract meaningless, just the motion. He then stated this contract will pass regardless of the vote.
