Mr. Glidden reviewed the scoring process and read the evaluation criteria. He stated that businesses have to get a total average score of 70 or above to get a favorable recommendation.

Custom Travel

Mr. Gross outlined the application. They qualify based on the submitted tax returns. They were impacted by COVID and are not back to pre-pandemic levels yet. They received PPP.

Committee comments on this application included:

- In 2021 they made more than the prior years.
- Not clear what they will do with the grant money and how it relates to the loss in prior years.

Diversafit

Mr. Regan outlined the application. They have been in town for three years. They provided P&Ls for 2019, 2020, and 2021. The funds are to be used to establish a brick-and-mortar studio, rent, and website for \$25,000. He suggested discussing a lower dollar amount since the grant request is more than they have made in the past.

Committee comments on this application included:

- There is a proportionality issue.
- Looking at revenue alone may be misleading.
- They are in the process of moving into a building.
- A proposal for reducing the grant to \$10,000 was made.
- They pivoted during COVID to build the business.
- They are trying to get back on their feet.
- Another suggestion was made for \$15,000

Would a lower amount change the scoring? The intent is not to enrich a company but help bring them back to being whole.

Mr. Glidden proposed scoring it based on a \$15,000 grant.

- No clean status letter from the State of CT due to taxes being in arrears. This means the application is incomplete.
- The rules set up by Council are that they can't use the funds for taxes.
- Suggested recommending no action due to incompleteness instead of saying no.

Motion to recommend no further action by this body in the matter of Wallingford Wine and Spirits due to the application being incomplete. (No clean State of CT Status Letter)

The funds will help him build guitars in town and rely less on outside international vendors. He will make more parts here. This goes along with what ARPA is for.

Committee comments on this application included:

- Sales went up every year.
- In 2021 he had a large depreciation.
- Uncertain how a contract could be written for the proposed use.

• Didn't see the negative impact of COVID.

There was a profit in 2020 and a loss in 2021. The funding request is fairly detailed to establish a brick-and-mortar with shop expenses. The application meets the criteria.

Committee comments on this application included:

- Would like to see more detail.
- Office expenses went up in 2021 without a clear explanation.
- Type of business that will have to change. They need to pivot.
- Business isn't recovering yet. This may be due to the delay in the change in the business model but not clear.
- Was creating signage nationally, now pivoting to local.

They are asking for \$25,000 towards the cost of repaving their parking areas and other projects that were planned before the pandemic. They will fund the remaining \$27,000 of the project costs.

Committee comments on this application included:

- Investing in improvements to their property.
- Good backup material.
- Uncertain of whether the funds will assist in the long-term recovery of the business.
- No proof that the drop in income is from tenants not paying rent.

- No detail on the amount of the grants they received.
- This is a successful business.
