

I would appreciate the Council confirming this appointment at the November 24th meeting.



Dear Mayor Dickinson:

At the last Council meeting there was a proposal by Mr. Walter Sawallich that residents be required to get a permit in order to access the Recycling Center. Ostensibly, the purpose of the permit would be to prevent non-residents from using the site. While no Council action was taken, there was an indication from the Council of interest in a permit program for the Recycling Center. After leaving the meeting, Mr. Sawallich, Mr. Tolla and myself continued the discussion about the need for a permit program.

Based on that conversation, it does not seem that there is a pressing interest in seeking such a program at this time. There are several reasons for this. First and foremost, under the current contract with our recycling vendor, there are no financial consequences to the Town should non-residents bring materials to the Center. The monthly charge to the Town for Center operations is the same regardless of total tons. Secondly, there is a cost to instituting and administering a permit program. These costs have not been budgeted. Thirdly, while permitting may prevent an occasional non-resident from using our service, it will no doubt cause complications for and complaints from our residents. I can imagine immediately hearing from an elderly resident who has a refrigerator to recycle but wants to borrow an unpermitted truck from his/her son who lives in a neighboring community.

At this point upon review of the situation, there would seem to be no immediate reason(s) for instituting a permit program. Should illegal use of the Center become more of a problem, a permitting program could always be considered.


