Mr. Bernick updated the Town Council on the progress of the New Haven-Hartford-Springfield Rail Project, speaking from the highlights listed in a handout that was supplied to the Town Council. His update included: a regional vision; the New Haven-Hartford-Springfield (NHHS) corridor; making connections to Grand Central Station, Penn Station and Boston and Bradley Airport and other locations; the 'why' to making the investment; current funding status; phase schedule with launch service in 2016. Mr. Bernick reviewed the two locations suggested for the terminal station in Wallingford and reported on town meetings. Chairman Parisi led the Town Council and members of the public in a question and response session.
