The Council, the Mayor and Mr. Thompson discussed the project, the grant and the grant process, the history of the project as it has unfolded since 2004 and the philosophy of this phase of the project, which combines the Hall Avenue Streetscape and the Senior Center connection to the Linear Trail. They examined funding timelines, the costs of the project with respect to grant funding and Capital and Non-Recurring funds, the town's portion, and that the two funding sources dovetail each other and should not be separated, according to the plan and its design. Other elements of the streetscape plan include street trees and brick sidewalks on Hall Avenue between Cherry Street and Route 5 to replicate the Quinnipiac Street enhancements. It was explained that in the last round of applications to the State of Connecticut, this same project ranked for the award funds, increasing the success of obtaining funding in this new application period. The agenda question addresses only the application for funding of this project. Other stages of funding come at a later time.

Councilors Fishbein and LeTourneau expressed their concern over lack of maintenance to existing street enhancements, such as the bricks in the sidewalk details and tree trimming.

Areas of concern were pointed out, and it was said that the town should not be entertaining a new project when it can't keep up with the maintenance of what the town now has.

Councilors Economopoulos and Sullivan echoed this concern along with views with regard to the economy and budgeting concerns, such as lack of paramedic funding. A section of the Capital and Non-Recurring fund allowances and restrictions was read by the Comptroller to augment the definition for a better understanding of the use of these funds and to explain that the town's portion of funds set aside for this project could not be used for maintenance.

Mayor Dickinson stated that people seem to like to come to the downtown area and that pedestrian traffic has increased as a result of the enhancement projects. He said that there will always be maintenance that needs to be done in town but that should not deter us from embarking on new things.

Councilor Farrell left the meeting for a short while about 7:15 P.M,. so that he could attend an event of his daughter. He expressed his desire to participate in the vote and asked if the vote on this item could be delayed until his return to the meeting.

### 5. PUBLIC QUESTION & ANSWER PERIOD

Robert Gross, 114 Long Hill Road, inquired whether DEEP has responded to the Mayor with regard to the use of the Covanta penalty funds; he inquired about reverse 911 and direct deposit

Wes Lubee, Montowese Trail, also inquired about direct deposit and then focused on a past meeting comment with respect to the word "shall".

Councilor Testa questioned the rationale of Item 6 and what would happen.

Town Attorney Janis Small responded that when the Council has had discussions regarding strategy in negotiations with respect to collective bargaining, it has always appeared on the agenda as an Executive Session with a reference to the statutory definition of 'meeting,' which exempts conversations regarding such matters. She said that in her research the FOI Commission, in fact, states that is technically not correct because it's not an "Executive Session," but rather a "non-meeting." She continued saying that if the Council is going to do it as part of the agenda, there are two options – one is to do it as it appears here where you basically take a recess from the meeting and have the collective bargaining strategy discussions, and then come back into the meeting. She said a second way would be to perhaps put it on the agenda to happen before the actual meeting starts stating the Council would be holding their collective bargaining discussions prior to the commencement of the meeting. Technically, to call it an Executive Session is not in compliance with FOI because it's really a non-meeting. Councilor Testa said he thinks that anytime there are five or more

Councilors gathered to discuss the business of the town that it becomes a meeting. Attorney Small said that according to FOI, the definition of 'meeting' excludes 'strategy and negotiations with respect to collective bargaining.' Under FOI with all nine Councilors gathered, it is not a meeting. She said, it is the section that has always cited as part of the Executive Session, which is the explanation for having the private meeting, when, in fact, it's technically not considered a 'meeting.' She discovered this when she saw an FOI decision that said that it should not be called an 'Executive Session.' She added that the Council gives the public more information that is needed by virtue of listing it on the agenda. Under the definition section of 'Executive Session,' 'strategy and negotiations with respect to collective bargaining' is not listed. Discussion must concern 'strategy and negotiations with respect to collective bargaining,' and the criteria here fits since the Council would be discussing within the collective bargaining process as to whether or not, this proposed contract will go into arbitration. She also added that the Council does not have to have a discussion.

Mr. Testa did not see the necessity of needing a 'non-meeting' and that the questions the Council has should occur here. He added that anything else talked about in a non-meeting be restricted to a discussion regarding the options open to the Council if the Council says 'no' to this contract, but everything else should be discussed in public.

Mayor Dickinson stated that this is slippery slope in that thought process is revealed in the questioning. Councilor LeTourneau asked that the two Councilors-elect attend a non-meeting session. Councilor Economopoulos stated that these are uncharted waters and that he does not like it. Councilor Sullivan stated that in his two years on the Council where many contracts were discussed that he does not recall ever talking about strategy. He said that he will not participate in a meeting in the back room and that all questions should be asked right here.

They talked about wages, steps, mileage reimbursement, and additional 'stipend', Annuity, step ranking of principals, Early Retirement Incentive Program, Co-pays and the reduction in the contract over the past contract, this contract has only three (3) steps, and the Discipline and Grievance processes.

The panel was congratulated on the work that has been done in bringing this contract to the Council and that the reductions have been noted that will result in considerable savings.

Councilor Farrell returned to the meeting at 8:07 P.M.

They discussed the timing of the contract to which the Town Attorney stated that the design of a template is underway.
